# City of Fort Wright Caucus Meeting Fort Wright Civic Club – 115 Kennedy Road Wednesday, April 17, 2024 – 6:00 PM

#### **CALL TO ORDER**

## ITEMS FOR DISCUSSION

Traffic Analysis of Kyles & Highland Intersection and Traffic Flow (CT Consultants) – Mark Bruggemann, Vice President, CT Consultants, presented a preliminary traffic analysis. He discussed various options and their positives and negatives. Mayor Hatter requested Mr. Brueggemann summarize the plans and present them back to Council when everyone was available to review.

Traffic Analysis of Kyles & Dixie Intersection and Traffic Flow (CT Consultants) – Mr. Brueggemann presented the preliminary analysis for this intersection, discussing positives and negatives about various options. He agreed to summarize the plans and present them back to Council when everyone was available to review.

Covington/Trails Land Swap Update – Ms. Bailey advised the President of the Mother of God Cemetery Board told her the Board is not interested in being part of a land swap with Covington now or in the future. There was discussion on the potential future development of the land the city of Covington is interested in, including land near Lookout Heights Lane. After discussion, Mayor Hatter requested Mr. Brueggemann confirm if there are bike trails on Fort Wright property.

**Stonewell Trail Driveway Access Request** – Ms. Bailey said a request was received from a Fort Mitchell resident whose backyard abuts Stonewell Trail in Fort Wright for a driveway access point through Fort Wright right-ofway. After discussion on grading and water issues, Councilman Weber expressed no concern with the request.

**Fort Wright Civic Club Building Tour and Facility Study** – Mayor, Council, and Staff toured the facility with Mr. Brueggemann so that a building study could begin.
