#### **NEW BUSINESS**

**Ordinance 04-2021 Occupational License Tax Rate** – Mayor Hatter said this is a Special Council Meeting to complete a second reading of Ordinance 04-2021, which would lower the occupational license tax rate from 1.15% to 0.99%.

Mr. Theissen read Ordinance 04-2021, an Ordinance of the City of Fort Wright, in Kenton County, Kentucky, amending the Ordinance codified as Section 110.26 of the Fort Wright Code of Ordinances, relating to the City's Occupational License Tax on employees, reducing the rate effective for the period beginning July 1, 2021. He read further, including Section 1 (A), which states that the occupational license fee that is levied and imposed by the chapter is at the rate of ninety-nine one-hundredths percent (0.99%), reduced from one and fifteen one-hundredths percent (1.15%), of all compensation earned by an employee for labor, work or services provided in the City.
