1<sup>st</sup> Reading Ordinance 08-2023 re: drive-thru restaurants only – Ms. Bailey advised the City applied for a text amendment with the Kenton County Planning Commission for the design options for the new Dunkin' property at 1826 Dixie Highway and KCPC has provided an action letter authorizing the text amendment. She said this Ordinance would officially make the change for drive-thru only restaurants in Fort Wright.

Mr. Theissen completed the first reading of Ordinance 08-2023, an Ordinance of the City of Fort Wright, in Kenton County, Kentucky, amending the Fort Wright Zoning Ordinance Title XV entitled Land Usage Code, Chapter 153 entitled Zoning, Section 153.01, and specifically Section 11.2 of the Fort Wright Zoning Ordinance, entitled "Specific Off-Street Parking Requirement" adding a new standard for drive-thru only restaurants at one parking space for every 300 square feet of gross floor area.

#### **NEW BUSINESS**

1<sup>st</sup> Reading Ordinance 05-2023 amending the FY22-23 Budget – Councilman Abeln thanked Mayor Hatter, the Finance Committee, and Ms. Bailey for their work on the budget.

Ms. Bailey advised the City is required to adopt a budget amendment annually to incorporate the audited fund balances. She said this is also an opportunity to clean up the budget and include anything that may have been authorized throughout the year, adjusting revenues and expenses to be closer to actual numbers. Councilman Weber commented on the amendment, saying the Finance Committee has reviewed it and agrees with the information.

Mr. Theissen completed the first reading of Ordinance 05-2023, an Ordinance of the City of Fort Wright in Kenton County, Kentucky, amending Fort Wright Ordinance No. 05-2022 and the budget adopted thereby for the City of Fort Wright for the fiscal year beginning July 1, 2022, and ending June 30, 2023.

1<sup>st</sup> Reading Ordinance 06-2023 adopting the FY23-24 Budget – Ms. Bailey introduced the summary budget, with the following notes:

- General Fund primary focus on recruitment and retention through competitive salaries, balancing
  inflation demands with keeping resident taxes low; some expenses for improvements to the City
  Administration Building and South Hills Civic Club
- Emergency Fund 15% of the previous year's audited expenses will be moved into this fund
- Municipal Road Aid the City is expecting approximately \$124,000 from the state from gasoline taxes and this funds salt and sand, signage, and some maintenance of City streets
- Parks & Recreation Fund ongoing maintenance of South Hills Civic Club and City parks; funds have been earmarked for a parking lot at Battery Hooper Park
- Dixie Kyles TIF this fund includes taxes from Fort Wright, Planning and Development Services of Kenton County, and Kenton County; no expenses planned at this time
- Fire/EMS Fund this fund is reserved for capital expenses for the Fire Department; no large purchases are anticipated, but some funds are earmarked for future purchases; the bulk of expenses will be related to a HRSA grant; approximately \$170,000 for renovations and equipment in the fire house
- Capital Improvements Fund this includes a wish list of items identified at a previous Caucus Meeting;
   also, two new Police Department vehicles; all amounts realized from investments will be placed into this fund.

Ms. Bailey said she typically budgets conservatively for revenues and liberally for expenses, but it is getting tighter than in the past.

Mr. Theissen completed the first reading of Ordinance 06-2023, an Appropriations Ordinance of the City of Fort Wright, in Kenton County, Kentucky, adopting the annual budget for the City of Fort Wright for the fiscal year beginning July 1, 2023, and ending June 30, 2024.

Fire/EMS Contract Renewals - Park Hills and Kenton Vale - Ms. Bailey advised a new two-year term is set to begin for contracted services with Park Hills for EMS services and Kenton Vale for fire and EMS services. She said the rate for Kenton Vale will be \$5,000 for the fiscal year of July 1, 2023, to June 30, 2024, and \$5,250 for the fiscal year of July 1, 2024, to June 30, 2024, and \$105,000 for the fiscal year of July 1, 2024, to June 30, 2025.

Ms. Bailey said there is a Municipal Order assigned to each contract, authorizing the Mayor to enter into the agreements with each City.

Councilman Wessels suggested increasing the amount for Park Hills in line with the City's expected budget increases. After discussion, Councilman Wessels made a motion to approve Municipal Order 04-2023 with the amendment to the contract with Park Hills to increase the second year payment total \$107,000. Councilman Weber made a second. Ms. Russell called the roll.

# **COMMITTEE REPORTS**

**Finance Committee** – Councilman Weber thanked Ms. Bailey and the department heads for their work on the budget.

**Community Improvement Committee** – No report.

## **CAO REPORT**

Ms. Bailey thanked the department heads for their work on the budget and amendment, and their diligence throughout the year.

#### **DEPARTMENT REPORTS**

Fire/ALS Department – No report

**Police Department** – Chief Butler said the new dash cameras for the police cruisers have been installed and are fully operational. He reminded residents of the vacation check program available through the department.

Chief Butler also provided an update on a letter sent to KYTC requesting they ban truck traffic on Kyles Lane/KY-3168. He said they responded advising the road is already rated at the lowest possible rating and the only other option is to step up enforcement. Chief Butler said he wrote back requesting additional signage be placed, but has not received a response.

**Public Works Department** – Mr. Bethell said Duke Energy and the Northern Kentucky Water District will begin their work on Fort Henry soon, which will cause traffic issues and delays. He recommended avoiding the area if you are able.

**Finance** – Ms. Perry advised less than 1% of real and tangible property taxes remain outstanding. She said the lien process will begin in July.

Administration – Ms. Russell advised passport acceptance and South Hills Civic Club reservations remain steady.

**Legal Counsel** – Mr. Theissen said he has been working on a challenging situation with a property at 420 General Drive, stating there have been 12-15 code violations over the last several years mostly related to exterior issues like junk in the driveway and mowing. He said that there has recently been an interaction with the residents and there appears to be a serious pest infestation inside the home, which not only poses a safety issue for the resident but could spread to neighboring homes.

Mr. Theissen advised Council there are two options: begin foreclosure on liens to force an ownership change or work through the code enforcement process with PDS to declare the building uninhabitable and force the residents to move or clean. He asked Council for the authority to begin both processes.

Councilman Weber advised he would abstain from voting.

Councilman Wessels made a motion to authorize Mr. Theissen to begin the foreclosure and code enforcement processes. Councilwoman Witt made a second. Ms. Russell called the roll.
