CITIZEN COMMENTS/GUESTS

Residents, Gary and Mary Lou Hansen who reside at 120 Kennedy spoke on what the future holds for the property located at 115 Kennedy. CAO Bailey explained there is currently a working group formed for community improvement, but no plans have been set for the property. She further states that the building had to be torn down due to safety issues involving the structure of the building. Councilman Wall adds that there are currently no plans to sell the property for developments and would likely be used for public use.

Andy Hogen – Atty for Arby's Restaurant on Madison Pk, spoke that he objected to an Ordinance declaring the Arby's Driveway becoming a public right-of-way. Grant Troja – President of Restaurant Mgmt.- Arby's Market concerned about traffic flow from between Sonic and Arby's.

Councilman Wessels had questions in regard to how the other Arby's Restaurants are configured with their traffic flow. Councilman Wessels suggested to table the first reading of the Ordinance as a courtesy to Arby's until this has been discussed in further detail. Councilman Wessels made a motion to table the 1st reading of the Ordinance of public right-of-way on Madison Pk between Arby's and Sonic. Councilman Weber made the second. NEW BUSINESS:

Walmart (Andrew Watson) - Temporary Outdoor Seasonal Storage Request

The representative from Walmart was expected to be at the meeting but was not present. Walmart is asking for a 30-day special consideration for 10 storage (shipping containers) from November 1 – Nov 30. Council mentions that this issue with Walmart is a constant battle and there are several violations that are sent throughout the holiday season due to Walmart having outdoor storage units for their holiday products. Council has additional questions, which can not be answered at tonight's meeting, sue to the Representative not present; topic will be tabled for a future meeting.

Certified City of Ethics Annual Training Program

The Ethics board is working through their process of Ethics requirements. 1st year – KLC will continue to conduct training. CAO Bailey had reached out to Michael Simon to set up training. The cost for KLC to conduct the training in January will be \$500. Money is allocated but will need to be voted on to allow the expenditure. Councilwoman Witt made a motion to approve the allocated expenditure contract. Councilman Wall made the second. Ms. Holland called the role.

Will establish the \$23/month per unit, for a yearly billed total of \$276 per residential unit. It will appear on tax bill as a separate line. We only received a bid from Rumpke for the new waste collection contract. Red or larger green recycling tote will be available free to residents. Residents may choose to use their own trash can or rent one from Rumpke for a small fee. City Attorney Brooking reads the 1st reading of Ordinance. Councilman Weber made a motion to accept the first reading of the Waste Collection fee Ordinance. Councilwoman Witt made the second. Ms. Holland called the role.

The Crack/seal program does not affect the 5-year plan. The 5-year program is now in review.

<u>Fire/ALS</u>- specs are out for bids on a new ambulance. Monitor defibs will be purchased by end-of-month.
