# **CITIZEN COMMENTS/GUESTS**

Randy Ellison – Mr. Ellison addressed Council regarding a proposal to remove the four billboards currently on his property at the corner of Madison Pike and Howard Litzler Road and replace them with two digital billboards. He said he wants to do this to clean up the corner as a gateway to the City. He said Lamar, the company who owns the billboards, is willing to work with him and the City to include "Welcome to Fort Wright" messaging in some way.

Ms. Bailey advised she has reviewed information Mr. Ellison has previously provided and does not have a response yet. She said there are a few issues relating to the existing signs and if they are grandfathered into excisting zoning regulations, as well as what the Kentucky Transporation Cabinet may allow because it is a state-owend road. Ms. Bailey said she thinks generally the zoning regulations will not allow for this change, but she will work on getting a firm response to Mr. Ellison.
