#### CITIZEN COMMENTS (after Schworer)

Ms. Dionna Sholler of Covington addressed the council and expressed gratitude and appreciation for the council and mayor for the very timely response looking into the issue with the dog on East Henry Clay Avenue. She asked if there was anything else to do as a collaborative effort for the animal. Mayor Hatter thanked her for the feedback and referred to Interim Police Chief Colwell. Chief Colwell reported that currently the ordinances are very loose but that the county was looking into stricter options. Animal Control reports that the owner is only has to provide access to a shelter, food every 48 hours, and water every day. The dog is an

Akita which is bred for extremely cold weather. The owner states that dog does not go into the doghouse and chooses to lay outside. It does not react well to being brought into the house. Officers are checking on it every day and every time someone calls in, it gets checked on. It is 100% an outside dog. As far as it is known, the dog is being taken care of according to the law. Mayor Hatter commented that Kenton County recently passed animal ordinance and recommended talking to Kenton County and possibly attending a Kenton County Commission meeting.

# **Verizon/MCI Telecommunications Franchise Agreement**

Mr. McMurtry provided background on this agreement and previous discussions stating that the agreement must be allowed. It is a legal right and sets guidelines. Mayor Hatter also provided an explanation of the agreement. Mr. McMurtry explained "right of way". He stated that the agreement had been revised with input from council. It is now a 5-year term as recommended by Tim Broering, Executive Director of Telecommunications Board of Northern Kentucky, because things are changing so quickly. City streets versus state streets was discussed. Fort Wright would only get the portion that involves city streets. The state is receiving 1.8-1.9%. The Fort Wright agreement increases the City's amount to 5% which is the upper limit of what is considered acceptable. Fort Mitchell is charging 3%. The minimal rental rate is \$8000.00 but may only be about 5 miles. This needs to be discussed to finalize and may need to be revised. Mr. McMurtry recommended \$5000 as it would be sufficient and protect city. Verizon is in agreement with this. Once it has been finalized, it will be put in place.

Councilman Weber asked if Council should we give Mayor Hatter the ability to make minor changes if negotiated. Mr. McMurtry responded, "Yes."

Councilman Feinauer made a motion to approve resolution to approve the agreement, put it out to bid, and allow the Mayor to negotiate a rate of 3-5% and rental of \$5000-\$8000. Councilman Abeln made a second. Treasurer/Senior Deputy Clerk Susan Ellis called the roll.

# **MAYORS COMMENTS**

Mayor Hatter provided additional comments regarding the meeting of the Finance Committee. He reported that the audit has been completed, and although the final report has not been submitted, there was nothing negative. He commented that the City has amassed substantial amount of cash and is "losing" money by leaving it where it is today. The Committee is reviewing financial restructuring and looking for additional secure and reasonable proceeds to generate substantially more income. Additional research is needed including review of the state laws and model investment policies from other cities

#### **DEPARTMENT REPORTS**

Administration/Finance - Treasurer/Senior Deputy Clerk Susan Ellis provided an update on taxes collected thus far. She reported that the new tax software is working well and providing noticeable time savings. Mayor Hatter reported that as a result of security issues he was choosing to err on the side of caution and that the City would be unable to accept credit cards this tax season.

**Fire/EMS Department** - Fire Chief Steve Schewe reported that Regis Huth, a Fort Wright resident, was hired as Fire Lieutenant and would be starting December 16, 2019. He also reported that the staff car came in today. They are still waiting for the ambulance and the return of the pumper back. He is working on confirmation date for a blood drive. Hoxworth will bring the mobile to the City. The event will be advertised.

**Legal Counsel** - City Attorney Todd McMurtry reported that he received an email from Ron Perry who is handling the CERS case reporting that the court decided not to take oral argument. He should hear soon from court of appeals. There will be opportunity to take up to supreme court if necessary.

Ms. Bailey added that as a result of changes with TBNK, this meeting was the first one broadcast through live streaming on internet. Effective in February, meetings held prior to August 2019 would not be available online. If someone needs a copy of the recording, they would need to complete an Open Records request.

Police Department – Interim Police Chief Jonathan Colwell reported that the onsite accreditation went through well. The Northern Kentucky Honor guard participated at the Veterans Day Ceremony. This month the Police Department will be participating in "Shop with a Cop". The Women's Self-Defense classes are on pause this month. He will be working on new dates and will be announcing them on social media.

**Public Works** - Public Works Director Jeff Bethell reported that the department has been getting ready for winter, winterizing, shutting off the sprinkler system, and doing leaf clean up. There was a small snow a couple weeks ago that provided a good opportunity to run routes and prepare. They have been installing new furniture around office building. The crushed sidewalk on George Huser should be completed.

The January meeting would be rescheduled as the first Wednesday is New Years Day. He also reminded everyone that taxes are due December 31<sup>st</sup>.
