#### ORDINANCE 02-2024

AN ORDINANCE OF THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AMENDING THE FORT WRIGHT CODE OF ORDINANCES CHAPTER 112 ENTITLED ALCOHOLIC BEVERAGES, SECTION §112.99, ENTITLED "PENALTY" ADDING A PROVISION AUTHORIZING THE CITY TO REVOKE OR SUSPEND AN ALCOLHOL LICENSE FOR NON-PAYMENT OF TAXES AND OTHER LEGAL VIOLATIONS.

**WHEREAS**, KRS 243.500 provides authority to revoke or suspend a liquor license for various causes enumerated in the said Statute;

**WHEREAS**, the City seeks to impose an additional penalty due to multiple occasions of violations by various operators of different businesses in the City who are delinquent in their taxes or otherwise not complying with City Ordinances or other laws; and

**WHEREAS**, the Fort Wright City Council desires to amend its Code of Ordinances to provide for the revocation or suspension of a liquor license held by a licensee in the City of Fort Wright for non-payment or non-compliance with its ordinances or other applicable laws by parties holding liquor licenses within the City; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF FORT WRIGHT, KENTON COUNTY, KENTUCKY, AS FOLLOWS.

## **SECTION 1**

The Code of Ordinances Title XI, entitled Business Regulations, Chapter 112 entitled Alcoholic Beverages, Section 112.99 entitled Penalties is hereby amended as follows (any text being added is shown by a single solid line drawn underneath it; text that is removed is marked at the beginning with an opening bracket and at the end with a closing bracket; the text between the brackets is stricken through with a single solid line).

#### **SECTION 2**

Section 112.99 is amended as follows:

### § 112.99 PENALTY.

- (1) Whoever violates any provision of this chapter shall be guilty of a misdemeanor and shall be fined not more than \$500.
- (2) Any license may be revoked or suspended by order of the City Alcoholic Beverage Control Administrator for the causes authorized by KRS 243.500, as may be amended from time to time, including but not limited to, for failure or default of a

licensee to pay an excise tax or any part of the tax or any penalties imposed by or under the provisions of any statutes, ordinances, or Acts of Congress relative to taxation, or for a violation of any related administrative regulations promulgated by the Department of Revenue, including any real estate taxes and occupational license or net profit taxes, insurance premium taxes, or any other taxes or payments owed to the City or its agencies.

# **SECTION 3**

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

### **SECTION 4**

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the city council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

# **SECTION 5**

That this ordinance shall become effective upon its passage and shall be published under KRS 83A.060(9) and other applicable law. This ordinance may be published by summary.
