ORDINANCE NO. 03-2021

AN ORDINANCE OF THE CITY OF FORT WRIGHT IN KENTON COUNTY KENTUCKY, AMENDING CHAPER 71, ENTITLES TRAFFIC CODES, IN THE FORT WRIGHT CODE OF ORDIANNCES, ADDING A NEW SECTION 71.06 PROHIBITING THE OPERATION OF COMMERICAL TRUCKS ON EAST HENRY CLAY AND WEST HENRY CLAY IN THE CITY OF FORT WRIGHT, AND PROVIDING PENALITIES FOR THE VIOLATION THEREOF.

WHEREAS, the City has suffered and is currently suffering from a serious risk of significant injury to both persons and property from larger commercial trucks driving on certain city streets that are not designed for them, nor capable of handling the trucks' size and weight; the property damage is both to the city streets, to the yards and improvements of property owners on said streets, and to other vehicles on said streets;

BE IT ORDAINED BY THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AS FOLLOWS:

SECTION 1

Chapter 71, entitled Traffic Rules" in the Fort Wright Code of Ordinances, is hereby amended to add a new section 71.06 entitled "Trucks Prohibited on Certain Streets", as follows:

71.06 Trucks Prohibited on Certain Streets

- (A) Definitions: As used herein, the following words and phrases have the meanings indicated for them:
 - (1) The word "anybody" means any human being, or any organization or combination thereof, in the form of a corporation, partnership, joint venture, unincorporated association or otherwise.
 - (2) The words "commercial truck" mean any motor vehicle with a gross vehicle weight rating (GVWR) of more than 33,000 pounds.
 - (3) The words "motor vehicle" mean any wheeled vehicle propelled by any means other than gravity or muscular power.
 - (4) The word "nobody" means no human being, or any organizations or combination thereof, in the form of a corporation, partnership, joint venture, unincorporated association or otherwise.
 - (5) The work "sign" means a sign designed, made, installed, and maintained according to the specifications of the Bureau of Highways of the Transportation Cabinet of the Commonwealth of Kentucky.
- (B) Sign Location: The Public Works Department of the City of Fort Wright shall cause signs prohibiting commercial trucks to be installed, located and maintained at the following locations:
 - (1) Within the southern side of the right of way of the street identified and known as East Henry Clay in the vicinity thereof in the right of way near 200 Kyles Lane so that the sign is facing motor vehicle traffic proceeding in an easterly direction on East Henry Clay.

(2) Within the northern side of the right of way of the street identified and known as East Henry Clay in the vicinity thereof in the right of way near 1206 East Henry Clay so that the sign is facing motor vehicle traffic proceeding in a westerly direction on East Henry Clay.

(3) Within the northern side of the right of way of the street identified and known as West Henry Clay in the vicinity thereof in the right of way near 117 Kyles so that the sign is facing motor vehicle traffic proceeding in a westerly direction on West

Henry Clay.

- (C) Prohibition: Nobody shall cause, promote, aid, assist, encourage, allow, or engage in the operation of any commercial truck with a gross vehicle weight rating of more than 33,000 pounds (including the load) to travel on our use any portion of the following city streets as a thoroughfare, except in connection with and in the ordinary course of business such as loading and/or unloading for the purpose of the delivery of goods and services from a seller to a buyer who is either a resident or owner of real estate which is contiguous to any portion of the street on either:
 - (1) Any portion of the street identified and known as East Henry Clay Drive;
- (2) Any portion of the street identified and known as West Henry Clay Drive.
 (D) Penalties: Each violation and every other failure to comply with the provisions of this ordinance shall be a violation; and each day of the continuation thereof shall be a separate and distinct offense for which everybody convicted thereof in a court of competent jurisdiction shall be sentenced to pay a criminal fine not to exceed the maximum amount of \$250.00 as set forth in K.R.S. 534.040(2)(c).

SECTION 2

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION 3

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the city council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

SECTION 4

That this ordinance shall become effective upon its passage and shall be published under KRS 83A.060(9) and other applicable law. This ordinance may be published by summary.

(3) Within the northern side of the right of way of the street identified and known as West Henry Clay in the vicinity thereof in the right of way near 117 Kyles so that the sign is facing motor vehicle traffic proceeding in a westerly direction on West

Henry Clay.

(C) Prohibition: Nobody shall cause, promote, aid, assist, encourage, allow, or engage in the operation of any commercial truck with a gross vehicle weight rating of more than 36,000 pounds (including the load) to travel on our use any portion of the following city streets as a thoroughfare, except in connection with and in the ordinary course of business such as loading and/or unloading for the purpose of the delivery of goods and services from a seller to a buyer who is either a resident or owner of real estate which is contiguous to any portion of the street on either:

(1) Any portion of the street identified and known as East Henry Clay Drive;

(2) Any portion of the street identified and known as West Henry Clay Drive. (D) Penalties: Each violation and every other failure to comply with the provisions of this ordinance shall be a violation; and each day of the continuation thereof shall be a separate and distinct offense for which everybody convicted thereof in a court of competent jurisdiction shall be sentenced to pay a criminal fine not to exceed the maximum amount of \$250.00 as set forth in K.R.S. 534.040(2)(c).
