ORDINANCE 03-2024

AN ORDINANCE OF THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AMENDING SECTION 153.02 OF THE FORT WRIGHT CODE OF ORDINANCES TO INCREASE THE COMPENSATION FOR THE MEMBERS OF THE CITY'S BOARD OF ADJUSTMENT TO \$250 PER YEAR.

WHEREAS, the City of Fort Wright has established a Board of Adjustment pursuant to KRS 100.217 and Section 153.02 of the Fort Wright Code of Ordinances; and

WHEREAS, KRS 100.217(7) authorizes the City to set the compensation for members serving on the Board of Adjustment; and

WHEREAS, Fort Wright Ordinance 1-2002 established the compensation for the members of the City's Board of Adjustment at \$75.00 per year;

WHEREAS, the Fort Wright City Council desires to amend the compensation to increase the amount to \$250.00 per year; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF FORT WRIGHT, KENTON COUNTY, KENTUCKY, AS FOLLOWS.

SECTION 1

The Code of Ordinances Title XV, entitled Land Usage, Chapter 153 entitled Zoning, Section 153.02 entitled Board of Adjustment is hereby amended as follows (any text being added is shown by a single solid line drawn underneath it; text that is removed is marked at the beginning with an opening bracket and at the end with a closing bracket; the text between the brackets is stricken through with a single solid line).

SECTION 2

Section 153.02 is amended as follows:

§ 153.02 BOARD OF ADJUSTMENT.

- (A) A Board of Adjustment is created pursuant to KRS Chapter 100.
- (B) The Board of Adjustment shall consist of five members to be appointed by the Mayor with the approval of City Council. The members of the Board shall serve for a term of four years, in accordance with KRS 100.217(4). The Board of Adjustment shall have all of the powers, duties, and responsibilities and be subject to all the requirements and limitations set forth in KRS Chapter 100 and other applicable statutes.

- (C) The members of the Board of Adjustment shall conduct their proceedings in accordance with KRS Ch. 100.
- (D) <u>Board of Adjustment members shall receive annual compensation of \$250.00</u> for their membership and participation on the Board of Adjustment, which compensation shall be paid in full once annually in July of the applicable fiscal year beginning in the 2024-2025 fiscal year from the General Fund of the City.

SECTION 3

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION 4

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the city council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

SECTION 5

That this ordinance shall become effective upon its passage and shall be published under KRS 83A.060(9) and other applicable law. This ordinance may be published by summary.
