ORDINANCE 08-2021

AN ORDINANCE OF THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AMENDING ORDINANCE 1-05 CODIFIED AS SECTION 32.21 OF THE FORT WRIGHT CODE OF ORDINANCES, RELATING TO THE CITY'S COMMITTEES AND THEIR MEETINGS.

WHEREAS, the Fort Wright City Council has reviewed the policies of the City relating to the use of committees and their meetings; and

WHEREAS, the Fort Wright City Council recognizes that (1) only a Finance Committee and a Community Improvement Committee is required; and (2) the Finance Committee and the Community Improvement Committee seek to amend their meeting schedule.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WRIGHT, KENTON COUNTY, KENTUCKY, AS FOLLOWS.

SECTION 1

That Chapter 32.21 of the Fort Wright Code of Ordinances, relating to meetings, is hereby amended as follows:

§ 32.21 MEETINGS.

- (A) The City Council will conduct its regular monthly legislative meeting on the first Wednesday of each month, at 6:00 p.m. at the Fort Wright City Building at 409 Kyles Lane, Fort Wright, Kentucky.
- (B) The City shall have a Finance Committee comprised of the Mayor and two city council members appointed by the Mayor, whose duties shall be to regularly review the finances of the City and to assist the Mayor in his duties under Section 33.03 (E) to prepare the City's annual budget proposal; the meetings of the Finance Committee [eommittee meetings for the city] will be conducted on the first Wednesday of each month at 4:30 [5:00] p.m. at the Fort Wright City Building at 409 Kyles Lane, Fort Wright, Kentucky. The City shall have a Community Improvements Committee comprised of three city council members appointed by the Mayor, whose duties shall be to identify and recommend to City Council projects that can be carried out by community volunteers and projects involving city-owned structures, assets, rights of way or property; the meetings of the Community Improvements Committee will be conducted on the third Wednesday of each month at 5:00 p.m. at the Fort Wright City Building at 409 Kyles Lane, Fort Wright, Kentucky.
- (C) The City Council will conduct a caucus meeting on the third Wednesday of each month at 6:00 p.m. at the Fort Wright City Building at 409 Kyles Lane, Fort Wright, Kentucky.
- (\underline{D} [\underline{C}]) Special meetings of the Council may be called by the Mayor or upon written request of a majority of the Council. In the call, the Mayor or Council shall designate the purpose, time, and place of the special meeting with sufficient notice for the attendance

of Council members and for compliance with KRS Chapter 61. At a special meeting no business may be considered other than that set forth in the designation of purpose.

 $(\underline{E} [\underline{D}])$ The minutes of every meeting shall be signed by the person responsible for maintaining city records as provided under § 31.36 and by the officer presiding at the meeting.

SECTION 2

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

SECTION 3

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the city council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

SECTION 4

That this ordinance shall become effective upon its passage and shall be published under KRS 83A.060(9) and other applicable law. This ordinance may be published by summary.
