

## ORDINANCE 04-2023

### AN ORDINANCE OF THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AMENDING THE FEE SCHEDULE FOR EMERGENCY MEDICAL AND TRANSPORTATION SERVICES

WHEREAS, Chapter 96 of the Fort Wright Code of Ordinances imposes by schedule, reasonable fees for emergency medical and transportation services;

WHEREAS, the Fort Wright City Council desires to amend the fees assessed in Section 96.02 of the Code of Ordinances due to increased costs associated with the services;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY OF FORT WRIGHT, KENTON COUNTY, KENTUCKY, AS FOLLOWS.**

#### SECTION 1

The Schedule of Fees for emergency medical or transportation services of the City of Fort Wright in TITLE IX, specifically Chapter 96, entitled Emergency Medical and Transportation Services, specifically Section 96.02 is hereby amended as follows (any text being added is shown by a single solid line drawn underneath it; text that is removed is marked at the beginning with an opening bracket and at the end with a closing bracket; the text between the brackets is stricken through with a single solid line).

#### SECTION 2

Code of Ordinances Section 96.02 "Schedule of Fees," is hereby amended as follows:

The schedule of fees shall be:

Non-emergency BLS	<del>\$450.00</del> <u>650.00</u>
Milage rate	<del>\$14.00</del> <u>15.00</u>
Emergency BLS	<del>\$600.00</del> <u>650.00</u>
Non-emergency ALS	<del>\$700.00</del> <u>850.00</u>
Emergency ALS	<del>\$800.00</del> <u>850.00</u>
ALS-2	<del>\$900.00</del> <u>1,000.00</u>
Oxygen rate	\$30.00
Defibrillation kit	\$225.00
Use of bag-valve-mask	\$50.00
Extrication fee	\$375.00

### SECTION 3

Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

### SECTION 4

If any part of this ordinance or its application is deemed invalid by a court of competent jurisdiction, the city council intends that such invalidity will not affect the effectiveness of the remaining provisions or applications and, to this end, the provisions of this ordinance are severable.

### SECTION 5

That this ordinance shall become effective upon its passage and shall be published under KRS 83A.060(9) and other applicable law. This ordinance may be published by summary.
