ORDINANCE NO. 01-2025

AN ORDINANCE OF THE CITY OF FT. WRIGHT, KENTUCKY, CLOSING THAT CERTAIN PUBLIC RIGHT OF WAY AS DESCRIBED ON EXHIBIT "A" ATTACHED HERETO, PURSUANT TO KRS 82.405.

WHEREAS, KRS 82.405 provides a method for a municipality to close a public right of way; and

WHEREAS, the City of Ft. Wright, Kentucky has considered and approved the closing of the public right of way as described in Exhibit "A" attached hereto; and

WHEREAS, the City of Ft. Wright, Kentucky deems it desirable and beneficial to close and transfer its ownership of the public right of way as described in Exhibit "A" attached hereto to DMG Rentals 14, LLC, being the sole property owner in or abutting the right of way to be closed;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF FORT WRIGHT, KENTUCKY, AS FOLLOWS:

SECTION I

The City of Ft. Wright, Kentucky has considered and approved the closing of the public right of way as described in Exhibit "A" attached hereto.

SECTION II

Pursuant to KRS 82.405(2), the City of Ft. Wright, Kentucky makes the following Findings of Fact:

- I. All property owners in or abutting the public right of way to be closed have been identified. The sole property owner in or abutting the right of way to be closed 1s:
 - a. DMG Rentals 14, LLC
 2500 Stapleton Court
 Cincinnati, Ohio 45240
- 2. The City of Ft. Wright, Kentucky has provided written notice to all property owners in or abutting the public right of way to be closed. The sole owner in or abutting the public right of way to be closed is DMG Rentals 14, LLC. A receipt of the written notice to DMG Rentals 14, LLC is attached hereto as Exhibit "B" and incorporated herein by reference.
- 3. DMG Rentals 14, LLC, the sole owner of property in or abutting the public right of way to beclosed, has given its written notarized consent to the closing, and a copy of that consent is attached hereto as Exhibit "B" and incorporated herein by reference.

SECTION ill

The public right of way as described in Exhibit "A" attached hereto is declared closed without further action pursuant to KRS 82.405, and all title in the real property described in Exhibit "A" shall pass to DMG Rentals 14, LLC, as the sole owner of property in or abutting the public right of way to be closed.

SECTION IV

All prior ordinances, municipal orders, or policies or parts thereof in conflict herewith, are to the extent of such conflict, hereby repealed.

SECTIONV

That the statements set forth in the Preamble to this Ordinance are hereby incorporated in this Ordinance by reference, the same as if set forth at length herein.

SECTION VI

The provisions of this Ordinance are severable and the invalidity of any provision of this Ordinance shall not affect the validity of any other provisions hereof, and such other provisions shall remain in full force and effect as long as they remain valid in the absence of that provision determined to be invalid.

SECTION VII

Upon its passage, this Ordinance shall be published according to law, and said publication may be in summary form.

SECTION VII

This Ordinance shall be in full force and effect when passed, recorded, and published according to law. Said publication may be in summary form.




