

ORDINANCE 09-19

AN ORDINANCE FIXING THE TAX RATE FOR THE FISCAL YEAR BEGINNING JULY 1, 2019, AND ENDING JUNE 30, 2020 UPON REAL ESTATE, PERSONAL AND MIXED PROPERTY IN THE CITY OF FORT WRIGHT, KENTUCKY, AND FIXING THE TIME AND PAYMENT AND PENALTY FOR NON-PAYMENT OF SAME.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT WRIGHT, KENTON COUNTY, KENTUCKY.

SECTION I

That an ad valorem tax of **0.279** on each One Hundred (\$100.00) Dollars value of real estate, and an ad valorem tax of **0.409** on each One Hundred (\$100.00) Dollars value of personal and mixed property, is subject to taxation for the fiscal year beginning July 1, 2019, and ending June 30, 2020. These funds will be used for ordinary municipal purposes to carry on the government of said City, including police protection, fire protection, repairs to streets, and furnishing street lighting.

SECTION II

The tax levied by the City Council of the City of Fort Wright, Kentucky for the year 2019 shall be due and payable to City Tax Collector from and after passage of this Ordinance. Anyone failing to pay the tax by December 31, 2019, shall be deemed delinquent, and said bill shall have added thereto a penalty of twenty (20%) percent of the amount thereof, and shall bear interest at the rate of twelve (12%) percent per annum from January 1, 2020, until paid. Said tax shall constitute a lien upon the property and be collectable as such.

SECTION III


Any and all Ordinances in conflict with this Ordinance shall be, and hereby are, repealed to the extent of said conflict.

This Ordinance shall take effect and be in full force from and after its passage, publication, which may be in summary form, and recording, according to law.
