

ORDINANCE 12-2024

AN ORDINANCE OF THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AMENDING VARIOUS SECTIONS OF THE TRAFFIC CODE OF THE CITY OF FORT WRIGHT TO AMEND LISTED STOP SIGNS, CLOSURES TO VEHICULAR TRAFFIC AND PARKING RESTRICTIONS, AMENDING CHAPTER 70 TO 75 OF TITLE VII OF THE CITY OF FORT WRIGHT CODE OF ORDINANCES.

WHEREAS, the Fort Wright City Council desires to update and amend its code of ordinances relating to its Traffic Code, codified in the City's Code of Ordinances as Title VII; and

WHEREAS, the Fort Wright City Council determines to amend Section 74: Traffic Schedules, Schedule 1. Stop Signs, as provided herein; and

WHEREAS, the Fort Wright City Council finds that the condition of Old Madison Pike has deteriorated to the point where closure to vehicular traffic is necessary to protect the safety of citizens of the area; and so City Council desires to amend its code of ordinances relating to its Traffic Code, codified in the City's Code of Ordinances as Title VII, specifically adding a "SCHEDULE III. STREETS CLOSED TO VEHICULAR TRAFFIC", and closing old Madison Pike to vehicular traffic in both directions at a point just south of existing driveway accessing 3864 Old Madison Pike, Fort Wright, Kentucky; and

WHEREAS, the Fort Wright City Council determines, upon advice of the Police Department, that safety dictates that parking be restricted in two places on Fort Henry Drive: (1) in that part of the south/west side of Fort Henry Drive between the driveway serving 422 Fort Henry Road and Amsterdam Road, due to the bend in the road and the traffic volumes it serves; and (2) on the north/east side of Fort Henry Drive for the fire lane between Amsterdam Road and Lookout Court;

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF FORT WRIGHT, KENTON COUNTY, KENTUCKY, AS FOLLOWS.

SECTION 1

The Traffic Code of the City of Fort Wright TITLE VII, specifically Chapters 70 to 75, is hereby amended as follows (any text being added is shown by a single solid line drawn underneath it; text that is removed is marked at the beginning with an opening bracket and at the end with a closing bracket; the text between the brackets is stricken through with a single solid line).

SECTION 2

§ 70.01 DEFINITIONS.

For the purpose of this title the following definitions shall apply unless the context clearly indicates or requires a different meaning

"AUTHORIZED EMERGENCY VEHICLES." Vehicles of the Fire Department, Police, Public Works Department, vehicles of the Commonwealth Attorney's office when on official business, and ambulances on an authorized emergency run.

"BOULEVARD." Any legally designated street at which cross traffic is required to stop before entering or crossing such boulevard.

"BUSINESS DISTRICT." Any portion of any street between two consecutive intersections in which 50% or more of the frontage on either side of the street is used for business purposes.

"CROSSWALK." That portion of the roadway included within the extension of the sidewalk across any intersection, and such other portions of the roadway between two intersections, as may be legally designated as crossing places and marked by stanchions, paint lines, or otherwise.

"CUL-DE-SAC." A cul-de-sac is that portion of a dead-end street (a street with only one intended inlet and outlet for vehicular traffic) which provides the vehicle ability to reverse its direction, including entire Perimeter of the traditional circle (an outlet at one end of a street with a permanent circular turnaround) and T-type turn-arounds (including temporary turn-arounds constructed to provide a method to turn around a vehicle during construction and development periods or during special events, that is not intended to be permanent).

"CURB." The boundary of that portion of the street used for vehicles whether marked by curbstones or not.

"INTERSECTION." That part of the public way embraced within the extensions of the street lines of two or more streets which join at an angle whether or not one such street crosses the other.

"OFFICIAL TRAFFIC-CONTROL DEVICES." All signs, signals, warnings, directions, markings, and devices placed or erected or maintained by authority of the Chief of Police or the Fort Wright City Council.

"ONE-WAY STREET." A street on which vehicles are permitted to move in one direction only.

"OPERATOR." Every person who is in actual physical control of the guidance, starting, and stopping of a vehicle.

"PARK." When applied to vehicles, to leave a vehicle standing, whether occupied or not, for a period of time longer than is necessary to receive or discharge passengers or property.

"PEDESTRIAN." Any person afoot.

"PLAY STREET." Any street or portion thereof so designated by the Chief of Police and reserved as a play area for children, from which all traffic is barred, except vehicles to and from abutting properties. "POLICE DEPARTMENT." The Police Department or other persons or agency authorized to perform the duties of § 70.03 or any other acts necessary to implement and enforce this traffic code.

"PUBLIC WAY." The entire width between property lines of every way, dedicated passway, or street set aside for public travel, except bridle paths and foot paths.

"REVERSE TURN." To turn a vehicle on any street in such a manner as to proceed in the opposite direction.

"RIGHT-OF-WAY." The privilege of the immediate and preferential use of the street.

"ROADWAY." That portion of any street, improved, designated, or ordinarily used for vehicular travel.

"SIDEWALK." That portion of the street between the curb and the property line intended for the use of pedestrians.

"STOPPING." As applied to vehicles, to stop a vehicle longer than is actually necessary to receive or discharge passengers.

"STREET." Every public way, including alleys.

"TRAFFIC." Pedestrians, ridden or herded animals, vehicles, buses, and other conveyances, individually or collectively, while using any street for the purpose of travel.

"TRAFFIC CONTROL DEVICE." The term "traffic control device" shall include stop sign, traffic signals (red-yellow-green lights including arrowed lights), yellow flashing lights, and any other official traffic-control devices; the term shall include all temporary signs, signals, warnings, directions, markings, and devices placed or erected or maintained by authority of the Chief of Police.

"VEHICLE." Every device in, on, or by which any person or property is or may be transported or drawn on any street except devices moved by human power or used exclusively on stationary rails or tracks

SECTION 3

§ 71.05 SPEED LIMIT.

(A) No operator of a vehicle upon a local city street or alley shall drive at a greater speed than is reasonable and prudent, having regard for the traffic and for the condition and use of the street or alley and in no event exceed a speed of 25 miles per hour except where otherwise posted, including on Farrell Drive where speed shall be limited to 20 miles per hour.

(B) Whoever violates the speed limit set forth in this section shall be subject to the fine schedule set forth in KRS 189.394.

SECTION 4

§ 72.03 LIMITATIONS OF STOPPING AND PARKING.

It shall be unlawful for the operator of any vehicle to stop or park such vehicle except in a case of a real emergency or in compliance with the provisions of this traffic code or when directed by a police officer or traffic sign or signal at any time in the following places:

- (A) On the mainly-traveled portion of any roadway or on any other place in the roadway where vehicles stand in any manner other than as specified in § 72.02.
- (B) On a sidewalk.
- (C) In front of sidewalk ramps provided for handicapped persons.
- (D) In front of a public or private driveway.
- (E) Within an intersection or crosswalk.
- (F) At any place where official signs prohibit stopping or parking. This does not apply to police officers when operating properly identified vehicles during the performance of their official duties
- (G) Within 30 feet of any flashing beacon, traffic sign, stop sign, or traffic-control device.
- (H) On any controlled access highway.
- (I) Within a highway tunnel.
- (J) Within fifteen (15) feet of a fire hydrant.
- (K) In an area between the roadways of a divided highway.
- (L) No person shall move a vehicle not lawfully under his control into any such prohibited area. (KRS 189.450(5), (6))
- (M) In a bus stop.
- (N) In a loading zone. ('77 Code, § 15-11) (Ord. 162-1978, passed 5-5-78)
- (O) On any unpaved surface in any zone within the city.
- (P) In any cul-de-sac.
- (Q) In any area so designated and identified by temporary signs, signals, warnings, directions, markings, and devices placed or erected or maintained by authority of the Chief of Police

SECTION 5

§ 72.10 PARKING IN PARKS.

It shall be unlawful for any person to park any motor vehicle in or on any section of any public park, playground, play lot, or tot lot within the city not designed as a parking area or designed and regularly maintained as a roadway. Parking shall be prohibited within any park from dusk to dawn.

SECTION 6

CHAPTER 74: TRAFFIC SCHEDULES

SCHEDULE I. STOP SIGNS.

(A) Nobody shall cause, promote, aid, assist, encourage, allow, or engage in the operation of any motor vehicle in the city, in such a manner that the motor vehicle passes any stop sign facing the motor vehicle and installed, located and maintained at any location indicated in the following schedule of stop sign locations, without the movement of the motor vehicle being fully and completely stopped immediately before passing the stop sign and the right of way yielded to any other motor vehicle at the intersection.

(B) The Public Works Department of the city will cause a stop sign to be installed, located and maintained within the rights-of-way at the intersections of streets identified in the following schedule so that the stop sign is facing motor vehicle traffic approaching the intersection in the direction and on the street indicated: Stop signs shall be erected at the following locations:

Alex Court @ Williams Creek Way – Southerly direction on Alex Court

Amsterdam Road @ General Drive – Southwesterly direction on Amsterdam Road

Amsterdam Road @ General Drive - Northwesterly direction on Amsterdam Road

Amsterdam Road @ Morris Road - Westerly direction on Amsterdam Road

Amsterdam Road @ Morris Road - Easterly direction on Amsterdam Road

Amsterdam Road @ Park Road - Easterly direction on Amsterdam Road

(B) Any violation of the provisions of division (A) of this schedule shall be a violation and a fine of not less than \$20 nor more than \$100 shall be imposed for each offense.

(A) No person shall cause, permit, aid, assist, encourage, or engage in the operation of a motor vehicle on the following streets at the locations identified:

SECTION 7

CHAPTER 75: PARKING SCHEDULES

(A) No person shall cause, permit, aid, assist, encourage, or engage in the location of a parked motor vehicle on any portion of the following described sections of streets within the city and it shall be unlawful to park a vehicle or truck at the following locations:

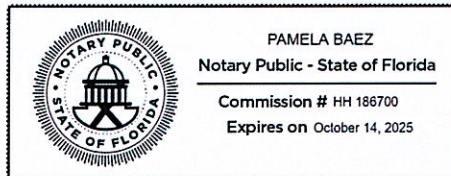

ORDINANCE 12-2024

AN ORDINANCE OF THE CITY OF FORT WRIGHT, IN KENTON COUNTY, KENTUCKY, AMENDING VARIOUS SECTIONS OF THE TRAFFIC CODE OF THE CITY OF FORT WRIGHT TO AMEND LISTED STOP SIGNS, CLOSURES TO VEHICULAR TRAFFIC AND PARKING RESTRICTIONS, AMENDING CHAPTER 10 TO 75 OF TITLE VII OF THE CITY OF FORT WRIGHT CODE OF ORDINANCES.

WHEREAS, the Fort Wright City Council desires to update and amend its code of ordinances relating to its Traffic Code, codified in the City's Code of Ordinances as Title VII; and

WHEREAS, the Fort Wright City Council determines to amend Section 74; Traffic Schedules, Schedule 1, Stop Signs, as provided herein; and

WHEREAS, the Fort Wright City Council finds that the condition of Old Madison Pike has deteriorated to the point where closure to vehicular traffic is necessary to protect the safety of citizens of the area, and so City Council desires to amend its code of ordinances relating to its Traffic Code, codified in the City's Code of Ordinances as Title VII, specifically adding a "SCHEDULE M. STREETS CLOSED TO VEHICULAR TRAFFIC", and closing Old Madison Pike to vehicular traffic in both directions at a point just south of existing driveway accessing 3854 Old Madison Pike, Fort Wright, Kentucky; and

WHEREAS, the Fort Wright City Council determines, upon advice of the Police Department, that safety dictates that parking be restricted in two places on Fort Henry Drive: (1) in that part of the southwest side of Fort Henry Drive between the driveway serving 422 Fort Henry Road and Amsterdam Road, due to the bend in the road and the traffic volumes it serves; and (2) on the northeast side of Fort Henry Drive for the fire lane between Amsterdam Road and Lookout Court;
